PLEASE NOTE:

• All references to the Cherry Valley, NY DMS10 switch are associated with CLLI code CHVYNYZVDS0 and will not be repeated throughout this notice.

• All references to the Oneonta, NY DMS100 switch are associated with CLLI code ONNTNYOADS0 and will not be repeated throughout this notice.

Description of the Planned Network Change(s):

The Verizon Cherry Valley, NY DMS10 switch, located at 73 Alden Street, Cherry Valley, NY 13320, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Oneonta, NY DMS100 switch, located at 17 Elm Street, Oneonta, NY 13820. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Oneonta, NY DMS100 switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Cherry Valley, NY DMS10 switch will be required to reposition the codes to the Oneonta, NY DMS100 switch.

All ASRs for the Oneonta, NY DMS100 switch must be received no later than April 14, 2024 to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Cherry Valley, NY DMS10 switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Cherry Valley, NY DMS10 switch (on or after June 3, 2024). This will serve to guide interconnect re-routes of traffic for the one (1) native code currently served by the Cherry Valley, NY DMS10 switch to reflect the Oneonta, NY DMS100 switch as the new home switch. All ASRs for the Oneonta, NY DMS100 switch must carry the project code of CHVYNYZVDS0.
