PLEASE NOTE:

- All references to the Freehold NJ VTOA Tandem switch are associated with CLLI code FRHDNJFHGT0/G0T and will not be repeated throughout this notice.
- All references to the New Brunswick NJ 04T Tandem switch are associated with CLLI code NBWKNJNB04T and will not be repeated throughout this notice.

Description of the Planned Network Change(s):

The Verizon Freehold NJ VTOA Tandem switch, located at 56 E. Main Street, Freehold, NJ 07728, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon New Brunswick NJ 04T Tandem switch, located at 18 Paterson Street, New Brunswick, NJ 08901. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the New Brunswick NJ 04T Tandem switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Freehold NJ VTOA Tandem switch will be required to reposition the codes to the New Brunswick NJ 04T Tandem switch.

All ASRs for the New Brunswick NJ 04T Tandem switch must be received no later than June 1, 2024 to provide sufficient time to migrate the traffic described above. Direct end office trunk (DEOT) interconnections will support traffic migration for the Freehold NJ VTOA Tandem switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Freehold NJ VTOA Tandem switch (**on or after August 1, 2024**). This will serve to guide interconnect re-routes of traffic for the seventeen (17) native codes currently served by the Freehold NJ VTOA Tandem switch to reflect the New Brunswick NJ 04T Tandem switch as the new home switch. All ASRs for the New Brunswick NJ 04T Tandem switch must carry the project code of **NBWKNJNB04T**.
