**Description of the Planned Network Change(s):**

The purpose of this notice is to provide your company with information regarding upcoming changes in Lata 228. The “**originating intra-lata (local)**” traffic that currently resides on the Wilmington 72T tandem for the codes of the 25 end offices in Lata 228 in Pennsylvania (see Table A below) will be moved back to the Market 90T tandem.

**Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):**

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers may need to augment the trunk groups built to the Market 90T DMS200 Tandem switch. All ASRs for the Market 90T DMS200 Tandem switch must be received no later than November 1, 2019 in order to provide sufficient time to migrate the traffic

described above. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to traffic reroute to the Market 90T Tandem switch (**on or after December 14, 2019**). This will serve to guide interconnect re-routes of the originating intra-lata traffic for the twenty-five (25) end offices listed above that are currently being served by the Wilmington 72T Tandem switch to reflect the Market 90T Tandem switch as the new switch for this traffic. All ASRs for the Market 90T DSM200 Tandem switch must carry the project code of **PHLAPAMK90T**.
