#### MINOR AMENDMENT

Bell Atlantic respectfully files this minor amendment to its Comparably Efficient Interconnection plan to offer Internet access services to add two existing tariffed services. These are ATM Cell Relay Service ("ATM") and Fiber Distributed Data Interface Network Service ("FDDI"). ATM is tariffed at the federal and state levels. FDDI is tariffed only with the states, because it has no interstate uses. Tariff references are provided in the Attachment.<sup>1</sup>

FDDI is technically limited in distance to approximately three miles and, therefore, is confined to use within a local area. There are also only "user to network" interfaces available for the service, not "network to network" interfaces, so it cannot be used to link with interexchange carriers to provide interstate access. As a result, there are no interstate uses of FDDI, and it is not tariffed at the Commission.

In each case, the end user will subscribe to the local ATM or FDDI service<sup>2</sup> and will connect, through the telephone company's local network, with an ATM or FDDI service subscribed to by Bell Atlantic's Internet access service to reach the Internet access server. There are no other changes being proposed in the enhanced service architecture.

ATM and FDDI have been available under tariff in all intrastate jurisdictions for more than ninety days, so no additional testing time is required. Accordingly, Bell Atlantic requests approval to use ATM and FDDI in connection with Internet access service.
