With many V Teamers working remotely and not requiring regular access to the office, we did an audit of our work locations to determine what makes sense moving forward. To be mindful of resources, we have decided to temporarily eliminate access to several offices that have remained mostly unoccupied since the start of the pandemic. Read this Q&A to learn more:

What does this mean for me?

Below is a list of offices that will be temporarily inactive. If you are in one of these work locations, please check to see if an alternate office is available should you need access to and are approved to enter. If no alternate office location is listed, please continue to work remotely until further notice.

Why are some offices being temporarily taken offline? How were these locations identified?

It takes significant resources and energy to keep offices operational. For the most part, office-based V Teamers continue to work from home with little need to regularly access their work location. With COVID-19 part of our reality for the foreseeable future, we want to be thoughtful of how we expend resources and find opportunities to conserve whenever possible. We audited work locations in the U.S. and identified those where a majority of employees are currently working from home and do not require regular access to a Verizon office.

What if I don't see an alternate location listed?

Employees should continue to work from their homes if there is no alternate location listed.

If there is an alternate location listed, can I access it at any time?

We are still following the same safety protocols and procedures. That means V Teamers who have rotating access to office locations will continue to adhere to the weekly schedule listed on the [COVID-19 Employee Resource page](#).

Alternate locations will take effect starting January 4, 2021. All social distancing practices remain in place, and any employees on site are required to wear face coverings. Please note, you must continue to certify through the Return to Office (RTO) tool on the days you intend to enter a Verizon location.
