Description of the Planned Network Changes:

Verizon New York Inc. will make changes to its Signaling System 7 (SS7) network and services. The deployment of an Oracle EAGLE 5 Integrated Signaling System (ISS) Signal Transfer Point (STP) in Verizon's Garden City, NY and White Plains, NY offices will accommodate the sale of the 21st floor at Verizon's E38th St. New York, NY office. The Manufacturer Discontinued Genband DMS STP and Oracle EAGLE 5 ISS STP on the 21st floor of E38th St. will be removed from service and the Signaling System 7 (SS7) links will be moved to a new Oracle EAGLE STP located at Garden City, NY. The Manufacture Discontinued Genband and Oracle STPs in White Plains, NY will be removed from service and the SS7 links will be moved to a new Oracle EAGLE STP in White Plains, NY.

Description of Reasonably Foreseeable Impact of the Planned Changes:

SS7 Service providers with SS7 link terminations in Verizon's E38th St., New York, NY office will be contacted prior to the SS7 link rearrangement activities to establish new carrier link terminations in the Garden City, NY office. Carriers will be required to relocate their SS7 links to the new Oracle STP in Garden City, NY STP within 30 days of the cutover of the new STP.

SS7 service providers and any other affected carriers with SS7 link terminations at Verizon's East 38th Street, NY office will need to alter their SS7 transport, OffNet services arrangements (services obtained from third parties) and/or Gateway services in order to access or continue serving customers served by offices that are currently homed to the East 38th Street and White Plains STPs.
