### Permission, Waiver and Release Statement for Minors ("Statement")

Labs are open to any child age 8–12 who signs up, at no cost, on a first-come, first-served basis and will be facilitated by Project Lead The Way ("PLTW"). Space is limited. Registration for the Labs can be completed at [www.verizon/learninglab](http://www.verizon/learninglab) until capacity is reached, as determined by Verizon and PLTW. Labs are offered at locations posted at [www.verizon/learninglab](http://www.verizon/learninglab). The schedule, location, or time of any Lab is subject to change, and are subject to cancellation without notice. Each child must provide a copy of this Statement, signed by a parent or legal guardian, to the PLTW instructor before the start of the Lab. All children must be accompanied by a parent, legal guardian or the designated adult substitute identified above for the duration of each session and each child will be released only to their parent, guardian, or designated adult at the end of each session, upon provision of proof of identification. Verizon and PLTW reserve the right to remove children from a Lab for unacceptable behavior, as determined by Verizon and PLTW in their sole discretion.

I hereby grant permission for my child to attend and participate in the Lab. I hereby forever release and discharge Verizon Communications Inc. and its directors, officers, employees, subsidiaries, affiliates, contractors, agents, and representatives (collectively "Verizon") and PLTW and its directors, officers, employees, affiliates, contractors, and agents (collectively "PLTW") from and against all claims and losses of any type arising out of or relating to my child's participation in the Lab. This release of liability shall extend to all claims of any kind involving or relating to any personal rights (including right of privacy and right of publicity), intellectual property rights or any other rights which I may have arising out of or in connection with Verizon's or PLTW's use of the Photography (defined below), property damage, bodily injury, or death suffered or sustained by me or my child. If necessary, I give permission for my child to receive emergency medical care, such consent not imposing a duty on Verizon or PLTW, or any of the individuals mentioned above, to provide such emergency medical care, and hereby forever release and discharge Verizon and PLTW from and against all claims and losses of any type arising from or relating to the provision or non-provision of such emergency medical care.

I understand and acknowledge that my child must comply with all applicable laws, policies, and regulations during and in relation to participation in the Lab, including any guidance relating to program device and data usage requirements. I agree to indemnify, defend, and hold harmless Verizon and PLTW from and against any and all claims, demands, losses, liabilities, and actions of any kind, including reasonable attorneys' fees, arising from or relating to my child's participation in the Lab.

I further give Verizon and PLTW permission to take and use, in any way whatsoever, for any purposes and in any manner, including, but not limited to, promotional, commercial and educational purposes, across any and all mediums, any photographs, testimonials, quotes, videotape, audio or soundtrack recordings of me or my voice, including the right to substitute the voice of another person(s) for my voice, to use my name, location, and biographical and other information (including information regarding my business) of me or my child collected during the Lab ("Photography") without any compensation other than any publicity received. I waive any right to inspect or approve the Photography or how the Photography is used and further waive any claim that I or my child may have with respect to its use. Additionally, at the end of the Labs, each child will be asked to provide suggestions, comments, ideas, and other feedback in connection with the Labs ("Feedback"). I agree that Verizon and PLTW shall own and retain all rights, title, and interest, including, without limitation, all intellectual property rights, in and to the Feedback.
