



XO IP Long Distance Business Plan

1.0 Description of Service. The XO IP Long Distance Business Plan is a single location, long distance calling plan available to Customers who subscribe to Company's local or long distance facilities-based service. Customer subscribes to one of the plans listed below based on anticipated monthly minutes required. Customer is responsible to pay the MRC each month, plus any overage based on the rates set forth below if Customer's actual usage exceeds the Included Minutes in Customer's plan.

2.0 Special Terms and Conditions.

2.1 Facilities-Based Services. To be eligible for IP Long Distance Business Plan ("Service"), a Customer must subscribe to Company's local exchange service, intraLATA toll, interLATA toll, and intrastate services or purchase interstate service via a dedicated IP facility (e.g. XO IP Flex, XO SIP or XO ESIP) at the Customer Service location.

2.2 Term Commitment. Customer must subscribe to the Service for a minimum of one year, as set forth in Customer's Service Order Agreement.

2.3 Single-Location Plan. The XO IP Long Distance Business Plan is a single-location plan. Customer must subscribe to the Service at the location where Customer receives XO Long Distance.

All rate plans chosen by Customer will be set forth on Customer's Service Order Agreement. Only XO Dedicated Domestic Interstate and Intrastate Long Distance (1+ and Toll Free) contribute to the Included Minutes ("Applicable LD Services"). Applicable rates for Canadian Toll Free calls are set forth in Section 4 below.

*Included Minutes does not include non-recurring charges, Long Distance Features, taxes and surcharges, including Universal Service Fund, and charges for equipment. Only Applicable LD Services billed on the same invoice will contribute to Included Minutes.

Monthly Recurring Charges (“MRC”) – XO will bill Customer and Customer agrees to pay the MRC for the applicable rate plan as indicated on the Service Order Agreement in each month during the Term of Customer’s Agreement. If Customer’s actual usage in any month exceeds the Included Minutes allotted for Customer’s plan, , XO will bill and Customer agrees to pay an amount equal to the Overage rate set forth above multiplied by the actual usage minutes in excess of the applicable Included Minutes.

Early Termination Penalties. If Customer cancels or terminates the Service, or XO terminates the Service for cause, prior to the end of the initial Term or any renewal Term, an amount equal to the MRC of the applicable XO IP Long Distance Business Plan multiplied by the number of months remaining in that term shall be immediately due and payable.

3.0 Long Distance Services. Long Distance Services refers to long distance usage outside of the local calling area (i.e., IntraLATA, Intrastate, Interstate and International). Unless otherwise set forth on XO's website at www.terms.xo.com with respect to specific Long Distance Plans, all Domestic Long Distance calls (i.e., IntraLATA, Intrastate, and Interstate calls) are billed in six (6) second minimums and six (6) second increments and rounded to the nearest penny. All other Long Distance calls, such as International Long Distance calls, will be billed in XO standard billing increments in accordance with the terms and conditions set forth at www.terms.xo.com. If in any given month more than ten percent (10%) of Customer’s Long Distance calls are six (6) seconds or less in duration (“Short Duration Calls”), then XO will bill, and Customer agrees to pay, a surcharge of one penny (\$.01) per call for such Short Duration Calls to be billed by XO in the following month or quarter, depending on the review period, as determined by XO.

Dedicated Long Distance Service Customers (e.g., private line access for long distances services) and their End Users should only utilize Dedicated Long Distance Service for their long distance traffic. Customers who place local calls across such service (intentionally or unintentionally) will be billed at the applicable Dedicated Intrastate Rate Per Minute and the associated charges will not be included toward Customer’s Included Minutes.

A XO IP Long Distance Business Plan provided pursuant to these terms may not be used in connection with Service provided to Carrier Customers, auto-dialers, data transmission equipment, or equivalent services, calls to Internet Service Providers, broadcast facsimile applications, or aggregated end-user traffic such as that undertaken by educational institutions.
