

**AMENDMENT No. 3 TO  
MASTER SERVICES AGREEMENT FOR GTA DIRECT SERVICES AGREEMENT  
98000-GTA Direct-CONTRACT-4666-VER**




This Amendment No. 3 is made this 20th of September, 2021, by and between the **GEORGIA TECHNOLOGY AUTHORITY ("GTA")** and **Verizon Business Network Services LLC on behalf of MCI Communications Services LLC d/b/a Verizon Business Services and Verizon affiliates ("Contractor")**.

WHEREAS, heretofore GTA entered into that certain Agreement for Services effective on **October 26, 2020** (the "Agreement"), with respect to certain services to be provided to GTA by Contractor, as more particularly described therein.

WHEREAS, the Agreement incorporated Exhibit 1 (Verizon's Product Catalog) containing a list of Verizon services and related service terms, service levels and pricing.

WHEREAS, the parties wish to amend the Agreement by removing the service terms from the Product Catalog and placing them in a separate and more accessible Service Attachment portfolio. The Service Attachment portfolio contains the service-specific terms and conditions governing the provision of each service ("Service Attachment Portfolio").

WHEREAS the parties wish to amend the Agreement by removing Virtual Communications Express and adding the following additional services (and related pricing) to the Product Catalog and Service Attachment Portfolio:

NOW, THEREFORE, in consideration of the premises, the terms and conditions stated herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. Virtual Communications Express. Virtual Communications Express is removed from Exhibit 1 of the Agreement. Verizon's WebEx Calling service replaces VCE.

- 2. Exhibit 1 – Product Catalog. Exhibit 1 of the Agreement (Verizon Product Catalog) is hereby deleted in its entirety and replaced with the attached Product Catalog 2.0. For clarity, the updated Verizon Product Catalog 2.0 reflects the addition of the above-referenced new services and related pricing.
- 3. Service Attachment Portfolio. Verizon’s Service Attachment Portfolio is hereby added to the Agreement.
- 4. Successors and Assigns. This Amendment No. 3 shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.
- 5. Entire Agreement. Except as expressly modified by this Amendment No. 3, the Agreement shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations of the parties. This Amendment No. 3 and the Agreement, collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
