Subject : Verizon Partner Solutions Industry Letter: Journal Square NJ 5ESS Switch Retirement

PLEASE NOTE:

- All references to the Journal Square NJ 5ESS switch are associated with CLLI code JRCYNJJODS5 and will not be repeated throughout this letter.
- •All references to the Rochelle Park NJ CS2K switch are associated with CLLI code RCPKNJ01PS0 and will not be repeated throughout this letter.

As set out in the Verizon New Jersey Inc. Public Notice of Network Change Under Rule 51.329(a), dated March 24, 2025, on or after October 1, 2025, the Journal Square NJ 5ESS switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) Codes in Numbering Plan Area (NPA) 201 currently residing in the Journal Square NJ 5ESS switch (see list in Table B below) will be moved to the Rochelle Park NJ CS2K switch (see details in Table A below).

The twenty-four (24) native NPA NXXs belonging to the Journal Square NJ 5ESS switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Rochelle Park NJ CS2K switch. This will occur on or after October 1, 2025.

Network Changes and Trunk Rearrangements:

The Rochelle Park NJ CS2K switch will be the recipient office of traffic migrated from the Journal Square NJ 5ESS switch. Traffic bound for the codes listed in Table B will be delivered via the New Brunswick 04T Tandem (NBWKNJNB04T).

After all traffic is migrated off of the Journal Square NJ 5ESS switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Rochelle Park NJ CS2K switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Journal Square NJ 5ESS switch will be required to reposition the codes to the Rochelle Park NJ CS2K switch.

All ASRs for the Rochelle Park NJ CS2K switch must be received no later than July 21, 2025, to provide sufficient time to migrate the traffic described above. All traffic must be moved by October 1, 2025.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Journal Square NJ 5ESS switch.
