Subject: Turtle Creek PA Gateway (TRKPATCGT0)

PLEASE NOTE:

 All references to the Turtle Creek PA VTOA Gateway switch are associated with CLLI code TRKPATCGT0 and will not be repeated throughout this letter.

- All references to the Pittsburgh PA Downtown 71T DMS 200 Tandem switch are associated with CLLI code PITBPADT71T and will not be repeated throughout this letter.
- The Turtle Creek PA VTOA Gateway switch is not listed separately in the Local Exchange Routing Guide (LERG). It is part of the Oakland PA VTOA Tandem switch (PITBPAOKG0T).

As set out in the Verizon Pennsylvania LLC "Short Term Public Notice Under Rule 51.333(a)," dated June 27, 2025, on or after November 7, 2025, the Verizon Turtle Creek PA VTOA Gateway switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information:

The Turtle Creek PA VTOA Gateway switch is not listed separately in the LERG. It is part of the of the Oakland PA VTOA Tandem switch (PITBPAOKG0T). Only the Exchange Codes (NXXs) in Numbering Plan Areas (NPAs) 412 and 724 subtending to the nine (9) end offices (see Table B below) supporting Local/Intra-LATA traffic via the Turtle Creek PA VTOA Gateway switch will be moved to the Pittsburgh PA Downtown 71T DMS 200 Tandem switch (see details in Table A below).

The NPA NXXs belonging to the Turtle Creek PA VTOA Gateway switch will be rehomed upon decommissioning of the switch and reflected in the LERG for the Pittsburgh PA Downtown 71T DMS 200 Tandem switch. This will occur on or after November 7, 2025.

Network Changes and Trunk Rearrangements:

The Pittsburgh PA Downtown 71T DMS 200 Tandem switch will be the recipient office of traffic migrated from the Turtle Creek PA VTOA Gateway switch. Traffic bound for the codes subtending the offices listed in Table B will be delivered via the Pittsburgh PA Downtown 71T DMS 200 Tandem switch.

After all traffic is migrated off the Turtle Creek PA VTOA Gateway switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Pittsburgh PA Downtown 71T DMS 200 Tandem switch or have

existing trunk groups to that switch augmented. Carriers that are code holders with connectivity in the Turtle Creek PA VTOA Gateway switch will be required to reposition the codes to the Pittsburgh PA Downtown 71T DM S200 Tandem switch. All ASRs for the Pittsburgh PA Downtown 71T DMS 200 Tandem switch must be received no later than September 1, 2025, to provide sufficient time to migrate the traffic described above. All traffic must be moved by November 7, 2025.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Turtle Creek PA VTOA Gateway switch.
