1. Please note that the cable route shown on the drawings are only indicative. The exact locations must be determined by the developer by means of trial holes prior to the commencement of any work. The developer is also required to give notice to **Verizon** prior to working in the vicinity of our cables (refer to Annex II).
2. The **Verizon** underground cable & Telecom duct are mostly non-metallic. The Cable Detection Worker is required to energise the trace wire inside the **Verizon** manholes for the detection works.
3. Assistance should be sought from the **Verizon** nominated Contractor in the opening of the manholes as they are protected by security locks.
4. No structure be it permanent or temporary may be erected over an **Verizon** duct.

 - f) I will stop all earthworks if the **Verizon** fibre optic cable is damaged and will immediately inform Network Maintenance, **Verizon**. (Tel: 6248-6768)
 - g) I will take all necessary precautions to safeguard and to avoid damage to the **Verizon** fibre optic cable
 - h) I will bear all costs relating to repairs for any damage(s) to the **Verizon** fibre optic cable
 - i) I will indemnify **Verizon** against all losses and claims arising from damage(s) to the **Verizon** fibre optic cables, inclusive of costs relating to the diverting of existing fibre optic cable
