

REFERENCE INTERCONNECT OFFER – FIXED VOICE CALL TERMINATION



### 1. Description of Service

Verizon Ireland shall convey Verizon Ireland National Termination Calls handed over from the Operator Network for termination to geographic number ranges in the Verizon Ireland Network.

Verizon Ireland National Termination Calls shall be limited to calls to geographic number ranges allocated to Verizon Ireland by the National Regulator, ComReg, or as otherwise required by ComReg.

# 2. Service Charges

All Charges stated in this agreement are subject to change from time to time due to changes in Verizon Ireland's third party supplier charges and/or changes in law/regulation (which includes a judgement of a court of competent jurisdiction), and such changes shall be effective from the date of the application of the rate change on Verizon Ireland, which for the avoidance of doubt may be retrospective.

It is understood that charges are subject to change for both parties, and that both parties will advise the other party in writing of any rate change as soon as is reasonably practicable however such obligation to notify the other party in writing is procedural only and does not alter the fact that such changes shall be effective from the date of the application of the rate change on Verizon Ireland. All notifications should be in line with those required under relevant regulation.

Verizon will apply its terms and conditions on a non-discriminatory basis in line with relevant regulatory requirements.
