PLEASE NOTE:

All references to the Hackensack VTOA Tandem switch are associated with CLLI codes HCKNNJHKG0T/GT0 and will not be repeated throughout this notice

All references to the Rochelle Park NJ CS2K switch are associated with CLLI code RCPKNJ0206T and will not be repeated throughout this notice.

Description of the Planned Network Change(s):

The Verizon Rochelle Park NJ 0206T DMS100 tandem, located at 65 W. Passaic Street, Rochelle Park, NJ 07662, switching function will change from switching only Inter-lata traffic to switching both Inter-lata and Intra-lata traffic. The HCKNNJHKG0T/GT0 tandem gateways located at 256 State Street, Hackensack, NJ 07601, will be retired and removed from the network. The Intra-Lata switching functions of the HCKNNJHKG0T/GT0 and tandem will be migrated to the Rochelle NJ 0206T. All traffic to be migrated includes Intra-lata (clec, independent, wireless, and paging) .switching function will change from switching only Inter-lata traffic to switching both Inter-lata and Intra-lata traffic. The HCKNNJHKG0T/GT0 tandem gateways will be retired and removed from the network. The Intra-Lata switching functions of the HCKNNJHKG0T/GT0 and tandem will be migrated to the Rochelle NJ 0206T switch, located at 65 W. Passaic Street, Rochelle Park, NJ 07662. All traffic to be migrated includes Intra-lata (clec, independent, wireless, and paging).

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s): Competitive local exchange carriers (CLECs), Independent, wireless carriers, and paging carriers will need to secure new trunk groups built to the Rochelle Park NJ 0206T tandem switch. Carriers that are code holders for connectivity in the HCKNNJHKG0T/GT0 tandem switch will be required to reposition the codes to the Rochelle Park NJ 0206T tandem switch.

All ASRs for the Rochelle Park NJ 0206T switch must be received no later than February 4, 2027, to provide sufficient time to migrate the traffic described above. Local Exchange Routing Guide (LERG) change effective dates will be posted, prior to decommissioning of the HCKNNJHKG0T/GT0 tandem switch (**on or after March 11, 2027**). This will serve to guide interconnect re-routes of traffic for the twenty-five (25) native offices currently served by the HCKNNJHKG0T/GT0 tandem switch to reflect the Rochelle Park NJ 0206T tandem switch as the new home switch.
