DIGITAL DIRECT INWARD DIALING SERVICE (DDID)

A. GENERAL

1. Digital Direct Inward Dialing Service (DDID) permits incoming dialed calls from the exchange network to reach a specific station line behind a customer system without the assistance of an attendant, through the use of a seven digit number.
2. DDID Service requires special central office equipment and is furnished only where facilities permit. The central office must be equipped with digital or equivalent equipment, and the telephone numbers must be available, in accordance with the current list of available central office codes. DDID Service is furnished only when the customer's system is compatibly equipped.
3. This service is normally provided from the central office which serves the customer's location. If DDID Service cannot be provided from the customer's local serving office, it can be furnished from another digital DDID equipped central office on a Foreign Exchange (FX) or Foreign Central Office (FCO) basis. In such cases, the FX or FCO rates and regulations specified elsewhere in this tariff are applicable in addition to the rates for DDID Service.
4. The monthly and nonrecurring charges specified for DDID Service are in addition to all other applicable rates shown elsewhere in this tariff or in other Telephone Company tariffs.

B. REGULATIONS

The regulations governing the provision of telephone numbers furnished in connection with DDID Service are as follows:

1. DDID Service telephone numbers are only furnished in groups of 25 numbers. Whenever possible, the Telephone Company will attempt to provide telephone numbers arranged consecutively in a group, but will not guarantee, nor accept responsibility for, the provision of such an arrangement.
2. Should provision of additional service necessitate telephone number changes, charges specified elsewhere in this tariff apply.

B. REGULATIONS (Cont'd)

3. DDID service is furnished upon the condition that the customer contract for adequate facilities, e.g., Type A trunks, or equivalent, etc., to permit the use of the service without injurious effect on the general telephone service in the serving central office. Certain conditions, such as transmission limitations, may require the provision of additional equipment in the serving central office and/or customer's premises in order to furnish DDID Service. Additional equipment or facilities may be furnished as shown in other parts of this Company's Tariffs or at rates based on cost. The Telephone Company may refuse to furnish, or refuse to continue to furnish, service for failure to comply with this regulation.
4. One directory listing is provided without charge for each customer system. Additional listings will be provided at rates specified elsewhere in this tariff.
5. Where DDID Service is furnished on more than one group of incoming station lines (telephone numbers), each such group shall be considered as a separate service and charged accordingly, and the service must be provided on all station lines in a station line group. A station line group is any quantity of central office lines bearing the same central office code.
6. Customer-Provided Switching Systems must handle calls to all assigned numbers, including those that are not currently used with Specific Stations. Calls to numbers not currently used with specific stations must be routed by the customer to a recorded announcement referring the caller to another number.

¹ In addition, each central office line equipped for DDID Service is charged the monthly rate for Type A trunk for the serving exchange as found Telephone-Pa. P.U.C. No. 5, Sections 1 and 1A.

² The subsequent NRC applies when DDID central office trunk terminations are added to an existing group of DDID trunks.
