PRELIMINARY STATEMENT

This Tariff contains the regulations, rates and charges applicable to the provision of interexchange telecommunications services by Verizon Select Services Inc. ("Carrier") for the use of Customers (T) transmitting messages within the state of California ("State"), subject to the jurisdiction of the California (T) Public Utilities Commission ("Commission").

Carrier has been authorized by the California public Utilities Commission in Decision No. 95-08-028 (dated August 11, 1995) to operate as a reseller of interLocal Access and Transport Area ("LATA") and, to the extent authorized by D. 94-09-065, intraLATA telecommunications services offered by communications common carriers in California.
