2. OPTIONAL TOLL CALLING PLAN SERVICE2

A. APPLICATION

Part 2 of this tariff applies to optional toll calling plan service between designated points within LATA's in the State of Pennsylvania. The points between which service is furnished on a local calling basis are indicated by the Local Exchange Tariffs governing the rates for exchange service.

Discounts associated with this service as set forth below will not be automatically applied to calls completed through the Pennsylvania Relay Service System. Subscribers must notify the Company of any calls made over the Relay Service System which are eligible for optional toll call plan discounts in order to receive the applicable discounts for those calls.

B. DEFINITION

Optional Toll Calling Plan Service is the furnishing of facilities for telephone communications between specified exchanges in different local service areas, in accordance with the respective regulations and system of charges specified in this Part for the Optional Toll Calling Plan Service or Services selected by the customer.

C. SELECTIVE EXCHANGE CALLING PLAN SERVICE1

Selective Exchange Calling Plan Service as set forth in this tariff is a discontinued service offering. Rates and regulations apply only to those Selective Exchange Calling Plan Service customers in Service on April 15, 2000. Existing customers may continue the service at the same location unless otherwise ordered by the Pennsylvania Public Utility Commission.

DESCRIPTION OF SERVICE

This service provides for one-way customer dialed station-to-station calling between specified exchanges at the rates listed under the Optional Toll Rate Schedule in addition to a monthly rate, as covered in 3. following.

Verizon North Discount Calling Service as set forth in this Tariff is a discontinued service offering. Rates and regulations apply only to those Discount Calling Plans in service on August 12, 1996. Existing customers may continue the service at the same location unless otherwise Ordered by the Pennsylvania Public Utility Commission.

1. Regulations

- a. Verizon North Discount Calling Service is an optional intrastate intraLATA Message Toll Telephone Service offered to certain business and residence exchange service customers in Verizon North LLC exchanges.
- b. The service provides an alternate rate treatment for Message Toll Telephone Service calls to exchanges within the customer's LATA. It is offered in three individually priced packages: Discount Calling Plan I, Discount Calling Plan II and Discount Calling Plan III. The service is applicable to customer dialed station-to-station and operator assisted calls as described below:
 - (1) Station-to-station service is that service where the person originating the call dials the telephone number desired or gives to the Company operator the telephone number of the desired telephone.

Two classes of station-to-station service are offered as follows:

- (a) Dial station-to-station is that station-to-station service where the person originating the call from other than a pay telephone dials the telephone number desired and the call is completed without the assistance of a Company operator or placed with an operator where facilities are not available for dial completion or where, for other service reasons, operator assistance in completion of the call is necessary.
- (b) Operator assisted station-to-station is that station-to-station service other than dial paid station-to-station service. The Verizon North Discount Calling Service rates only apply to the message toll portion of the call, not to the operator surcharge portion.
- c. The service is provided with discounted call detail.
- d. The minimum service period for each Discount Calling Plan is one month. A customer may only subscribe to one Discount Calling Plan, per account, at any given time.
- e. No customer may simultaneously subscribe on the same telephone line to more than one optional calling plan.
- f. The service is not offered in connection with Pay Telephone Line Service or Foreign Exchange Service.
- g. The method of applying rates for Verizon North Discount Calling Service is as set forth elsewhere in this tariff.
- h. The application of usage rates and timing of messages is as set forth elsewhere in this tariff.
