INTEREXCHANGE TELECOMMUNICATIONS SERVICES TARIFF

APPLICABILITY

This tariff applies to Intercity Telecommunications Services furnished by MCI Communications Services, Inc. between and among points within the State of Michigan.

Effective August 1, 2001, pursuant to the direction of the Federal Communications Commission (FCC), MCI is canceling its federal tariffs for services with certain exceptions, including those pertaining to exchange access, casual calling, and basic long distance service during a 45-day period for customers who sign up for MCI service with a Local Exchange Carrier (LEC). International services for Residential and Small Business customers will also remain tarified through January 27, 2002.
