This tariff contains the rules, regulations, descriptions and rates applicable to the furnishing of local exchange telecommunications services offered by MCImetro Access Transmission Services LLC d/b/a Verizon Access Transmission Services (hereinafter referred to as the "Company") within the State of Michigan to residential and small business (i.e., mass market) customers. Local exchange telecommunications services offered to large business and enterprise customers are not contained in this tariff, but instead can be found in the Company's "Service Publication and Price Guide" (The Guide) located on the Company's Internet site at [www.verizonbusiness.com/publications/service\\_guide](http://www.verizonbusiness.com/publications/service_guide).

Per amendments to the Michigan Telecommunications Act (MTA) dated November 21, 2005, which also supercede the Commission order of December 21, 2004, in Case No. U-14309 (In the matter of the application of and complaint, or in the alternative a request for a declaratory ruling by MCImetro Access Transmission Services LLC, for determinations regarding rates of end-user local service bundled with unregulated features or options, and request for emergency relief), the only retail rate regulated service in Michigan is Primary Basic Local Exchange Service, tariffed herein as Residential R7 Service. Accordingly, all other retail rates contained in this tariff should no longer be considered to be subject to regulation by the Michigan Public Service Commission.
