## SECTION 13 - SPECIAL CONSTRUCTION AND SPECIAL ARRANGEMENTS (Cont.)

### 13.1 Special Construction (Cont.)

- (a) where facilities are not presently available, and there is no other requirement for the facilities so constructed;
- (b) of a type other than that which MCImetro would normally utilize in the furnishing of its services;
- (c) over a route other than that which MCImetro would normally utilize in the furnishing of its services:
- (d) in a quantity greater than that which MCImetro would normally construct;
- (e) on an expedited basis;
- (f) on a temporary basis until permanent facilities are available;
- (g) involving abnormal costs; or
- (h) in advance of its normal construction.

## 13.2 Basis for Charges

Where MCImetro furnishes a facility or service on a special construction basis, or any service for which a rate or charge is not specified in MCImetro's tariffs, charges will be based on the costs incurred by MCImetro and may include: (1) non-recurring type charges; (2) recurring type charges; (3) termination liabilities; or (4) combinations thereof. The agreement for special construction will ordinarily include a minimum service commitment based upon the estimated service life of the facilities provided.

# 13.3 Basis for Cost Computation

The costs referred to in 13.2 preceding may include one or more of the following items to the extent they are applicable:

- (A) cost installed of the facilities to be provided including estimated costs for the rearrangements of existing facilities. Cost installed includes the cost of:
  - (1) equipment and materials provided or used,
  - (2) engineering, labor and supervision,
  - (3) transportation,
  - (4) rights of way, and
  - (5) any other item chargeable to the capital account;
- (B) annual charges including the following:
  - cost of maintenance;
  - depreciation on the estimated cost installed of any facilities provided, based on the anticipated useful service life of the facilities with an appropriate allowance for the estimated net salvage;
  - (3) administration, taxes and uncollectible revenue on the basis of reasonable average costs for these items;
  - (4) any other identifiable costs related to the facilities provided; and return (5) an amount for return any contingencies.

### 13.4 Termination

To the extent that there is no other requirement for use by MCImetro, a termination liability may apply for facilities specially constructed at the request of the customer.

#### 13.4 **Termination**

- 1. The maximum termination liability is equal to the total cost of the special facility as determined under 13.3, preceding, adjusted to reflect the, redetermined estimate net salvage, including any reuse of the facilities provided.
- 2. The maximum termination liability as determined in paragraph (1) shalt be divided by the original term of service contracted for by the Customer (rounded up to the next whole number of months) to determine the monthly liability. The Customers termination liability shall be equal to this monthly amount multiplied by the remaining unexpired term of service (rounded up to the next whole number of months), discounted to present value at six (6) percent, plus applicable taxes.

#### 13.5 Extension of Line Facilities

Extensions of line facilities for exchange service will generally be made without construction charges under the normal construction programs of the MCImetro to meet the needs of present or future applicants for new permanent telephone exchange service to permanent premises for year round occupancy.

An extension of MCImetro facilities in location, where MCImetro facilities do not exist will generally be made as follows:

Cable - Line extensions requiring cable will be placed for a distance of 1000 feet A. per residence or per business customer without charge to the customer requesting service. A facility charge will apply to the customer for a line extension in excess of this standard allowance (1000 feet). The intent of this tariff is to eliminate facility charges in any platted subdivision or mobile home park.

13.5 Extension of Line Facilities (Cont.)

B. Service Drop Wire - Extensions requiring drop wire will be placed for a distance of 250 feet without charge to the customer requesting service. A facility charge will apply to the customer for an extension in excess of this standard allowance (250 feet).

## SECTION 14 - TEMPORARY PROMOTIONAL PROGRAMS

MCImetro may establish temporary promotional programs under which it may waive or reduce non-recurring or recurring charges, to introduce present or potential Customers to a service not previously received by the Customers. The specific terms of each promotional program shall be filed with the Commission within 30 days of its effective date.
