This tariff contains the rules, regulations, descriptions and rates applicable to the furnishing of Local Exchange Service offered by MCImetro within the State of Indiana, Indiana Code Sections 8-1-2-1, et seq., and 8-1-2.6-1 et seq. and the Order of the Indiana Utility Regulatory Commission in Case No. 48075, issued December 3, 1997.

This tariff, MCImetro Access Transmission Services LLC d/b/a Verizon Access Transmission Services I.U.R.C. No. 1, cancels and replaces, in its entirety, the current tariff on file with the Indiana Utility Regulatory Commission, MCImetro Access Transmission Services Corp. d/b/a Verizon Access Transmission Services I.U.R.C. Tariff No. 1.
